Reference to the Gulf Health Council's intimation regarding the above mentioned product's recall in its country of origin due to finding that the product is not bio-equivalent with its reference product and also the different batches of it showed non compliance with approved specifications.

We have therefore decided to recall the above mentioned product with immediate effect from the market. The healthcare professions are advised to stop prescribing and dispensing the product forthwith and return the available stock, if any, to M/s. Scientific Pharmacy, who are the local agent of the product, under intimation to us.

The healthcare professionals are kindly requested to report any adverse events or side effects associated with the use of the above product or any other medicinal product to the Department of Pharmacovigilance & Drug Information in DGPA&DC.
